

BELLY FLOP CONTEST OFFICIAL RULES

On June 16, 2024, Hyland Hills Park and Recreation District, d/b/a, Water World, and its employees, directors, officers, volunteers, and agents (collectively, the "District") will host the Water World Belly Flop Contest (the "Contest"). By entering this Contest and/or accepting or using any prize, Contestant agrees to abide by, and be bound by these Belly Flop Contest Official Rules and the decisions of the District relating to participation in the Contest, selection of the Contest winners, and award of prizes, all of which shall be final.

NO PURCHASE NECESSARY TO ENTER OR WIN.

ELIGIBILITY: TO BE ELIGIBLE TO PARTICIPATE IN THE CONTEST, ENTRANTS MUST BE 21 OR OLDER AND ABLE TO SWIM. ALL ENTRANTS MUST (1) COMPLETE THE BELLY FLOP CONTEST ASSUMPTION OF RISK, RELEASE, WAIVER, AND COVENANT NOT TO SUE PRIOR TO PARTICIPATION; (2) PRESENT A CURRENT DRIVERS LICENSE OR OTHER VALID FORM OF IDENTIFICATION SHOWING FULL NAME AND DATE OF BIRTH; AND (3) PRESENT PROOF OF A VALID SOCIAL SECURITY NUMBER, AS WINNING CONTESTANT INFORMATION IS SHARED WITH THE IRS FOR TAX REPORTING PURPOSES.

Employees of the District and their respective family members (parent, child, spouse, sibling and their respective spouses, regardless of where they reside) and household members, whether related or not, are not eligible to enter the Contest.

Whether an entrant has met the eligibility requirements to participate in the Contest will be determined in the sole discretion of the District.

All times stated herein are Mountain Daylight Time (MDT).

<u>CONTEST QUALIFYING PERIOD</u>: The Contest qualifying period begins on June 1, 2024 at 6:00AM and ends on June 16, 2024 at 12:00PM ("Qualifying Period").

<u>HOW TO ENTER</u>: Individuals interested in participating in the Contest may register online at WaterWorldColorado.com. The first twenty (20) qualified entrants will be accepted to participate in the Contest (the "Contestants"). A Contestant's qualification to participate in the Contest shall be determined in the sole discretion of the District. During the Qualifying Period, the District, in its sole discretion, may extend or amend the Qualifying Period and/or Contest requirements.

EVENT PERIOD: The Contest will take place Sunday, June 16, 2024, from approximately 12:00PM to 1:30PM.

<u>CONTESTANT BENEFITS</u>: For participating in the Contest, Contestants will receive one (1) complimentary admission ticket and one (1) complimentary meal plan ticket, both valid only at Water World on June 16, 2024.

<u>COSTUMES</u>: Contestants, at their own risk and expense, may wear costumes that do not obstruct the view of their assigned Contestant number. Contestants shall be solely liable for determining the safety of their

costume. However, the District may, in its sole discretion, prohibit costumes deemed to be inappropriate or a safety hazard (such as additional weights or objects that may impede a contestant from safely exiting the pool). Contestants may not receive any assistance from any other persons during the Contest.

<u>CHECK-IN INSTRUCTIONS</u>: Contestants must check in for the Contest between 9:40AM – 10:00AM on June 16, 2024 at the Group Sales Office, located at the main entrance to Water World, 8801 N. Pecos St., Federal Heights, CO 80260. Contestants must present a valid photo ID, a valid social security number, and bring the attached, fully completed Belly Flop Contest Assumption of Risk, Release, Waiver, and Covenant Not to Sue. Contestants will receive their admission ticket and meal plan ticket at check-in and will have all bags screened for safety, in accordance with District policy. Contestants who fail to check in prior to 10:30AM may be disqualified from the Contest and forfeit applicable admission and meal plan tickets, such disqualification and/or forfeiture to be determined in the sole discretion of the District.

Once checked-in, Contestants will go to the staging area to have an assigned number painted on their body so the District and judges can identify each Contestant. Contestants may request additional paint designs on their body, subject to District approval. Drinking water will be provided to Contestants inside the Contest area.

<u>JUDGING</u>: Judges will score Contestants on a 1-10 points system for overall entertainment value, with 1 representing the worst score and 10 representing the best score. Judging determinations shall be made in the sole, subjective discretion of the District and its selected judges.

EVENT COMPETITION: The Contest will begin on June 16, 2024 at approximately 12:00PM. The first round of the Contest will consist of one (1) jump per Contestant. Each Contestant will "flop" off of "The Cove" deck platform in the order of the number they received at check in. Contestants will receive a score from the judges after each flop. The top three (3) scoring Contestants will advance to the Finals Round. In the event of a tie, there will be one (1) jump off from the tied Contestants, and the judges will choose the winning belly flop and that Contestant(s) will advance to the Finals Round. Contestants that do not advance to the Finals Round will be required to stay in the Contest area until the event concludes.

The Finals Round will begin at approximately 12:45PM-1:00PM. The three finalists (in order based on number) will "flop" from the Lifeguard Platform.

At the end of the Finals Round, scores from all Contestants will be accumulated, and the winners with the top five (5) highest cumulative scores will be announced. In the event of a tie, there will be one (1) jump off from the applicable Contestants. The judges, in their sole subjective discretion, will choose the winning belly flop.

Please Note: For eligibility to receive a Contest prize, Contestants must remain in the immediate area of the Contest for the duration of the competition (approximately 10:30AM-1:00PM).

<u>WINNER NOTIFICATION</u>: All Contest winners will be announced on-site at the conclusion of the Contest. All Contest winners must provide a copy of his/her valid personal identification card bearing his/her photograph, name, age, and address, and proof of their valid social security number prior to receiving any prize. The execution of additional releases and/or waivers of liability required by the District and/or any other applicable sanctioning body or prize provider may also be required to be completed within seven (7) days of a request from such entities, as appropriate.

- 1ST PLACE: \$1,000 cash prize
